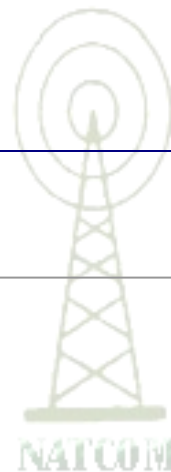

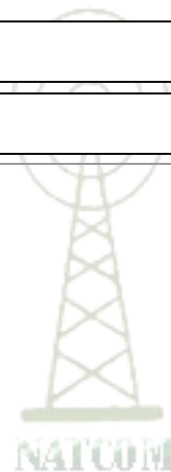

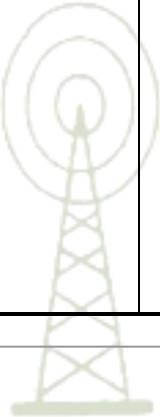

Notes for Applicants

1. **In accordance with the Telecommunications Act 2006, amended 2009 the appropriate licence must be held to cover possession or use of radio equipment. Possession or use of radio equipment without a licence is an offence which renders the offender liable to prosecution and, on conviction, fines and confiscation of equipment.**
2. **This application form sets out the standard information that is required for an Aircraft Radio licence. In certain cases, the Commission for Communications Regulation (National Telecommunications Commission) may seek further information or clarification from the Applicant.**
3. **Applications for an Aircraft Radio Licence with authority from the Ministry of Transport and Aviation must be submitted in writing either via post (at address below) or fax (232-22-235855):**

4. **To submit a valid application it is necessary to:**
 - **Submit the application form in writing as per point 3 above.**
 - **Complete ALL sections of the form, entering N/A if applicable.**
 - **The Aircraft Call-Sign number (i.e. Registration Number on the Register of the Sierra Leone Civil Aviation Authority) must be entered on the form.**
 - **Part 2 of this form; “Aircraft Radio Licence Statement of Stations” (Technical Information), must be printed.**

Application forms not adequately completed cannot be considered as valid applications and will be returned to the applicant.

5. **To avoid a situation where National Telecommunications Commission cannot issue an Aircraft Radio Licence by the required date, we recommend that all applications be submitted a minimum of 2 weeks prior to the requirement date.**
6. **To process an application written technical approval from the Sierra Leone Civil Aviation Authority (SLCAA) is required. To facilitate speed of processing, please e-mail the technical information on the application form to dg@natcomsl.com**
7. **Please attach any additional information on a separate sheet(s), indicating the appropriate section and question.**
